This agency is responsible for the processing of crime victims requests for financial assistance and reimbursements. Our agency also administers state and federal grants, which includes:

Services, Training, Officers and Prosecutors (STOP) Violence Against Women Act (VAWA) and the Sexual Assault Services Program (SASP) Formula Grants from the Office of Violence Against Women (OVW)

Victims of Crime Act, VOCA Victim Assistance Formula Grant, VOCA Victim Compensation Formula Grants and Discretionary grants which are federally funded programs from the Office for Victims of Crime (OVC)
