Review Agenda

Commission Members reviewed the agenda and Commission Chair Summa asked for a motion to approve the agenda. Commission Member Rogers made the motion to approve. Commission Vice Chair Karst seconded the motion. The motion to approve the agenda was passed unanimously.

Review and Approval of October 26, 2023, Commission Meeting Minutes

Commission Chair Summa and Commission members reviewed the Commission meeting minutes for October 26, 2023. Commission Member Brown made a motion to approve the meeting minutes. Commission Vice Chair Karst seconded the motion. The motion to approve the minutes passed unanimously.

Agency Financial Report

Ms. Mok updated the Commission regarding the fiscal year FY2024 budget position report regarding victim payments for the period of July 1, 2023, through November 13, 2023.

The victim payment budget started in the amount of \$2,579,000. The compensation victim batch payouts as of October 27, 2023, is in the amount of \$1,063,764 with available budget of \$1,515,236.

In addition, Ms. Mok informed the Commission that CVRC's weekly projected payouts are \$53,000. Ms. Mok stated that there are 35 weeks remaining in the fiscal year with a projected total of \$1,864,235 to close out FY2024.

Ms. Mok informed the Commission that CVRC will have a negative balance of \$348,999 if we continue at the current weekly payout.

Ms. Mok presented the FY 2023 Crime Victim Fund Budget Status report to the Commission. Below are the payments received for the period of July 01, 2023, to November 13, 2023, by type:

Restitution: \$26,067 Corrections: \$155,252 Civil Settlement: \$8,172 Penalty Assessment: \$42,977 Total received: \$232,468

Ms. Mok reviewed the Crime Victims Funds Status report with the Commission, totaling \$232,468.

Ms. Mok informed the Commission that payments received from the Department of Corrections have been inconsistent. This is likely due to the Department of Corrections' new computer software system.

In addition, Ms. Mok informed the Commission that the Administrative Office of the Courts (AOC) penalty assessment payments received are listed through September and are lower than expected.

In conclusion, Ms. Mok stated that the FY2024 Crime Victim Fund budget projected \$315,000 in funds and has a deficit of \$82,532 in funds received as of today's date.

Mr. Zubia informed the Commission that the judges have started not imposing the fines and fees that affect our agency's Crime Victim Fund.

FY23 CVRC Annual Agency Audit

Ms. Mok was pleased to announce to the Commission that the FY23 CVRC Annual agency's audit had no findings. Ms. Mok stated that this was the fifth audit of the year.

Mr. Zubia added that the auditing firm asked for extensive information on samples from state and federal programs. The auditor inspected every CVRC program associated with compensation and assistance.

Mr. Zubia shared with the Commission a comment the auditor gave him and Ms. Mok: Our record keeping is immaculate. In addition, the auditor expressed that our invoices, policies, and procedures are well explained and kept in order.

Mr. Zubia complimented Ms. Mok and the staff for doing a great job and said it was a team effort.

Ms. Mok and Mr. Zubia thanked the Commission and Commission Chair Summa for participating in the exit audit.

Commission Chair Summa and Commission thanked the staff for a great job.

Mr. Zubia informed the Commission that CVRC can provide a draft copy of the audit if requested by Commission Members. Typically, CVRC provides a final approved copy when it is sent to our agency.

New Business

NM CVRC Rules and Regulations (Proposed Changes)

Mr. Zubia informed the Commission of CVRC rules and regulations and proposed changes.

Mr. Zubia informed the Commission that Attorney General Tenorio will attend the afternoon session to review proposed changes with the Commission.

In addition, Mr. Zubia informed the Commission that he anticipates these proposed changes will be available before the Legislative Session starts in January 2024.
